

# **Nurminen Logistics Plc to issue new shares in the company to the company itself without consideration**

The Board of Directors of Nurminen Logistics Plc (the “Company”) has, pursuant to the authorization granted to it by the Annual General Meeting held on 11 April 2022, yesterday evening resolved to issue 133,078 new shares in the Company to the Company itself without consideration in accordance with Chapter 9, Section 20 of the Finnish Companies Act (624/2006, as amended). The new shares to be issued are of the same class as the existing shares in the Company. The total number of the Company’s shares after the share issue is 78,101,654 shares, of which 65,262 shares in total are held by the Company.

The shares to be issued in connection with the share issue to the Company will be used for the payment of the remuneration of the Board members and/or for the creation of incentives for or encouraging commitment in, personnel.

The new shares are estimated to be registered with the Finnish Trade Register on or about by 26 July 2022 after which the Company will, without undue delay, apply for the admission of the shares to public trading on the official list of Nasdaq Helsinki Ltd.
